

## IMPROVEMENT OF LEGAL SERVICE ACTIVITY

**Abstract:** In the article, citizens of the Republic of Uzbekistan today on further improvement of legal services the work carried out in our country and foreign countries in this regard about the use of experiences.

The current demand is that every citizen living in a democratic country should fully know and understand his rights, duties and opportunities. In order to fill the gaps in this regard, there are types of legal services in each country. It is no exaggeration to say that citizens will have the opportunity to live comfortably through legal services.

It is known that the legal service plays a very important role in building a strong legal state, in developing the culture of legal consciousness of citizens, in ensuring the rule of law in the activities of state authorities and business entities. In our country, which continues to develop day by day, the role of the legal service in the state administration and management is increasing. Due to the fact that the number of entrepreneurship and economic subjects is increasing, making good use of the conditions created in our country, the need for objects that provide legal services is also increasing.

Over the past period, comprehensive measures have been taken to ensure the rule of law and legality in the activities of state bodies, economic management bodies, state enterprises, institutions and organizations. However, it is worth mentioning that in our country, reforms aimed at providing legal support for the activities of state bodies and organizations, especially at the middle and lower levels, and providing them with quality and professional legal services are being implemented step by step. At the same time, deficiencies in the involvement of experienced personnel in the field have a negative impact on the quality of the economic, financial and legal examination of draft documents. As a result of this, decisions and other documents are often the cause of local objections by individuals and legal entities.

In order to fill such existing deficiencies, the Decision of the President of the Republic of Uzbekistan dated June 29, 2021 "On measures to further improve the legal services of state bodies and organizations" and based on this Decision "Legal "On Service Centers" Regulation was adopted. This Regulation defines the status, main duties and functions, rights, obligations and responsibilities of the Legal Service



Centers under the Ministry of Justice of the Republic of Karakalpakstan, regional and Tashkent city justice departments, as well as the procedure for organizing their activities. Based on this, from October 1, 2021, legal service centers were established in all districts (cities) of the Republic under the Ministry of Justice of the Republic of Karakalpakstan, regional and Tashkent justice departments, and from October 4, 2021, the Centers will resume their activities. started Of course, such centers are very important today. In keeping with the times, every individual and legal entity of our country must know their rights. The above-mentioned legal service centers play an important role in the consistent and legal, and most importantly, fair resolution of appeals received from citizens.

The effectiveness of law enforcement and law enforcement practices is directly related to the quality of drafts of normative legal documents prepared by state authorities and management bodies. In this case, the legal service of each organization has a great responsibility.

Therefore, special attention is paid to improving the quality of legal services in our country. The normative legal framework in this direction has been completely updated, and government decisions aimed at determining the status of the legal service have been adopted. In addition to the development of dozens of departmental normative legal documents, practical activities are regularly organized by the judicial authorities to provide methodological support to this field and to develop it. In addition, legal service employees are being trained at the Lawyers Training Center under the Ministry of Justice. Taking all this into account, the decisions made by our president are being implemented step by step.

The decisions taken by the President of the Republic of Uzbekistan in order to further strengthen the legality in the activities of state bodies and organizations, and to consistently strengthen the role and responsibility of legal services in the implementation of democratic and legal reforms, the interests of the people and the demands or needs of citizens are considered first of all.

On the other hand, various countries with experience in this matter are using their own direction and measures. Therefore, it is advisable to use the useful experiences of experienced countries in this field.

Two years ago, within the framework of the joint project "Improving the provision of state services in rural areas of Uzbekistan and increasing the level of local governance", work was carried out on creating the necessary amenities for the population.

It would not be wrong to say that the international experience in providing services to the population was learned and paid off within the framework of this project implemented by the United Nations Development Program in cooperation with the European Union and the Ministry of Justice of Uzbekistan.



When the experience of Latvia in providing services to the population was studied within the framework of the joint project, it became known that special services are provided to the vulnerable segment of the population in this country. This experience, which is compatible with universal human values, was also introduced in Uzbekistan and is currently bearing its results. In other words, women's advisory groups are being organized at State Service Centers, where women and persons with disabilities are provided with practical assistance in providing public services. At the end of 2021, the experience of Germany and the Czech Republic in providing public services was studied within the framework of a joint project. At the same time, they got acquainted with how citizens of Uzbekistan living in this country use public services. Today, more than 7,500 citizens of Uzbekistan are registered in this country. The members of the delegation consisting of experts first met with the Ambassador Extraordinary and Plenipotentiary of the Republic of Uzbekistan to the Federal Republic of Germany, Nabijon Kasimov. During the meeting, the existing problems related to remote use of the Registry of Civil Status and state services by our compatriots living in Germany, especially the provision of necessary information in the provision of electronic services and consular services through electronic information exchange, were discussed. the necessary measures to solve it were determined. Currently, our compatriots are making good use of these opportunities, and this has significantly reduced their unnecessary hassles and red tape.

In the dialogues, the relations of local authorities with the private sector, nongovernmental organizations, citizens and practical mechanisms of relations, regional development programs, the role of central and local authorities in regional development programs, citizen participation, public administration and decentralization in Germany, federalism and local administration, etc. topics were discussed. In addition, the members of the delegation will get acquainted with the state and local government system in Bavaria, get acquainted with the territorial and functional administrative reforms implemented and ongoing in Bavaria, and other meetings will be held in Prague, the capital of the Czech Republic. management system, local budgeting and fiscal decentralization, e-government and public service provision activities.

The most important thing is that the system of providing public services to the population will be further improved on the basis of international best practices.
