By examining the basic tense structures, the role of aspect, morphological marking, and syntactic constructions, we aim to illuminate the similarities and differences between English and Uzbek verb tenses. In English, the primary verb tenses include the simple present, simple past, simple future, present continuous, past continuous, future continuous, present perfect, past perfect, future perfect, present perfect continuous, past perfect continuous, and future perfect continuous. Similarly, Uzbek also has a range of verb tenses to express similar temporal concepts.

Form of Verb Tenses:

In English, verb tenses are formed by combining auxiliary verbs (such as "be," "have," or "will") with the base form of the main verb. For instance, the simple present tense is formed by using the base form of the verb, while the present continuous tense requires the auxiliary verb "be" in its present form along with the present participle (ing form) of the main verb. The formation of other tenses follows a similar pattern with the appropriate auxiliary verbs.

In Uzbek, verb tenses are formed by adding specific suffixes to the base form of the verb. For example, the simple present tense is formed by adding the suffix "yapman" for the first person singular, "-yapsiz" for the second person singular, and "yapti" for the third person singular. The present continuous tense is formed by adding the suffix "-yapayotgan" to the base form of the verb. Other tenses in Uzbek also have their respective suffixes for conjugation.

Similarities and Differences:

Both English and Uzbek languages have similar verb tenses to express actions in various time frames. However, there are notable differences in terms of their formation. English relies heavily on auxiliary verbs, while Uzbek employs specific suffixes for each tense. Additionally, English has more complex tenses like the present perfect continuous or future perfect continuous, which may not have direct equivalents in Uzbek.

Before dividing the present tense into classification, we decided toconsider the works of scientists in classification of all the tenses of Englishand Uzbek.Each of the scientists divided the verb-tenses according theirinvestigation. In is necessary to point out that the divisions should becorresponded to the rule of attitude of the action to the moment of speech.Ganisheva M. A [1] divide English verb-tenses into primary and secondarytenses. The primary tenses are all the non-perfect tenses in common and continuous aspects. The perfect tense in common and continuous aspects is the secondary tense. This is the common division of verb-tenses. A number of scientists as Kobrina N.A, Korneyeva E.A, Ossovskaya M.I [2], consider that, verbtenses should be perfectand non-perfect. We cannot say that. this definition is valuable. Ivanova I. P., Burlakova V. V., Pochetsov G.G [6] divided the verb-tensesinto aspect. We think that, only this is the right classification of the verbtenses of the English language. Virtually, the category of tense in both languages has got three moments of action: present, past and future and in many grammar guides each of theseverb-tenses were divided into groups. Thus, the clearer division is met in the works of Ivanova I. P. She divided the verb-tenses of English into 3 categories: 1) the main category 2) the continuous category 3) the perfect category

From the scheme below it defined that, indefinite categories express repeated, custom, common actions; continuous classification identifies going on actions; perfect categories deal with completed actions.
